**RE : Paul Grundy**

This is to advise that we have been employed by Paul James Vincent Grundy to act on his behalf.

We have been instructed in respect to your anticipated action to publicly announce that our client is "no longer one of Jehovah's Witnesses" and by so announcing, encourage fellow Jehovah witnesses to disassociate and otherwise "shun" him.

Paul is well known amongst the community of Jehovah's Witnesses. All people aware of such an announcement understand that such an announcement signifies that he is either disfellowshipped or disassociated and most probably an apostate. For this reason, Jehovah witnesses will apply the highly defamatory remarks made within any Watchtower publications or announcement to his person, and be forced to shun him in line with Watchtower policy.

Paul also stands to lose significant business dealings by such an announcement as many Jehovah's Witnesses have continued to use his services yearly for accounting advice and also eat at his salad bar.

To date, actions taken by Luc Kikkert and associated Jehovah Witness brothers against Paul over the last twelve months including unannounced visitations at night, amount to harassment and have caused our client significant emotional distress and resulted in



medical appointments, current use of prescription medicine and a referral to a psychiatrist for religious induced stress. Any public announcement is most likely to exacerbate such conditions.

Accordingly, we request that all harassment of our client cease immediately including telephone calls and uninvited visitations to our client's residence and all further communication with our client be in writing. Any attempt to slander or otherwise defame our client or any attempt to approach our client at his home, work place or in any public place will result in police intervention and the commencement of judicial proceedings.

We trust that you will give this matter your urgent attention.
